- Minimum 5 years of experience in Infrastructure and / or Hospitality Projects anywhere in the Country.
- The applicant should have completed minimum 5 Infrastructure and / or Hospitality projects whose capital cost excluding the land cost is at least INR 10 Crore each in the last five years.
- Turnover of applicant should be INR 3 Crore (Rupees Three Crore only) from Infrastructure or hospitality projects as on 31st March 2019.
